The lack of enforcement of state and local laws related to the use of illegal fireworks in Bend has impacted severely the livability of our neighborhood. As a board, we have been in the forefront of bringing this issue to City Council's attention and were instrumental in forming a working group to address it. We are participants and fully support the work of the Bend Neighborhood Association (NA) Illegal Fireworks Working Group and we endorse the information submitted by that group for City Council's consideration as part of its goal prioritization process.

What is the biggest problem your organization believes the city faces?

A public WIFI network for the Bend community - we propose that the City of Bend provide a basic level of internet service via a public WIFI network that is available to all who are within City limits. The issue of inequity amongst the residents of Bend continues to be a concern, especially in regards to how COVID-19 is affecting people. Even before the added hurdles of Covid-19, not having access to reliable WIFI meant many people, but especially students, did not have a means to engage in our modern world. No access to WIFI means school kids can't access their public education; it means citizens in search of employment can't send in that resume or apply online; it means remote workers cannot utilize work-from-home options; it means out-of-work citizens not able to apply for employment benefits; it means residents cannot access information and news online, bank online, connect with loved ones online, etc. With our world shifting more and more to an online platform for basic services like those listed above, those who lack access to WIFI are being left behind.

Who could be other partners to address this problem? If we solved this problem, what would the outcome look like? Paint a vision.

Local partners for this project could be Bend Broadband and the Bend-La Pine School District. Other financial backers could be found as well, but those two local partners immediately come to mind. The school district because it would benefit the student population and Bend Broad Band because they have the expertise and the infrastructure to provide this service.

If we solved this problem, it would mean families able to stay at home for comprehensive distance learning and not have to drive around town looking for free WIFI to use or depend upon a WIFI hot spot. When in-person classes resume, these students' school-issued iPads would become the useful learning tool they are intendent to be. As we know, students who lack WIFI at home can't use their school-issued iPads, a problem more students face than we realize. Having easy access to WIFI would ensure all Bend residents have the ability to utilize online services, but it could also benefit those who already have WIFI at home. If there is a disruption in service, the public WIFI would be there to fall back upon.

If you know of suggested plans or objectives to achieve this change, please describe.

We are not aware of existing plans or objectives to achieve this change. We do know the Bend La Pine School District has purchased hot spots for students lacking internet access and that Bend Broadband has discounted the price of some of its services to families lacking adequate internet access, but both these efforts have been piecemeal and limited in scope. The biggest obstacle we foresee will most likely be cost – who will pay is usually the most essential issue on a project like this. Residents may oppose the idea if it leads to an increase in fees or taxes. Also, internet providers might worry that public WIFI might mean they lose customers and therefore they might oppose the idea.

Describe practical steps to measure progress toward the goal.

Steps most likely would include a committee to review the feasibility of the project and to elicit partners into the process. Then, proposals would be collected for work needing to be done, etc. Not being an expert in this type of project ourselves, the steps are a bit hard to envision, but progress towards the goal might be breaking Bend into zones and implementing WIFI in each zone, adding more and more areas of the City over time, with a goal of having the whole community covered by a certain year.
